As cast, crew, volunteer or legal guardian for the minor applicant, you consent to participation in this production hosted by Mid-Valley Productions (hereafter recognized as MVP). You realize the potential for injuries, and understand that it is the intent of MVP to provide for the safety and protection of all participants, but injuries may still occur. In consideration for volunteer participation in MVP's events and productions, you hereby forever release Mid-Valley Productions and Linn-Benton Community College, their Board of Directors, and production staff from all liability, and for any and all damages and injuries occurring during the rehearsal process, build/educational workshops, run of the production, or publicity event(s) hosted or sponsored by MVP. I hereby agree to individually provide for the possible future medical expenses which may be incurred as a result of injury sustained while building, rehearsing, performing, or volunteering for MVP.

You acknowledge that MVP may take pictures/video of its participants for use with marketing (print and digital) and within its website/social media . MVP is not responsible for any personal items that may be lost, damaged, or stolen during the rehearsal process, build/educational workshops, run of the production, or publicity event(s) hosted or sponsored by MVP.

You acknowledge that your participation in MVP productions is a commitment. By accepting any role(s) you are offered, you are agreeing to attend the rehearsals you are scheduled for. You will be on time, prepared, and present. If you are sick or feeling unwell, you will communicate any absence to the directing staff immediately and will stay home to prevent the spread of illness to the cast/crew. You understand that it is your responsibility to communicate any issues directly to the production staff so they may be addressed and handled appropriately.

Hitchin' Agreement

By agreeing to the terms and conditions box in virtual audition application form. The applicant and or parent/guardian of the minor applicant acknowledges that MVP's production of *Hitchin'* includes the following adult themes; discussion of sex and sexuality, marijuana use, light profanity, and portrays a political protest scene. By agreeing to the terms and conditions box in the virtual audition application form you are aware and comfortable with this information and content.

If applicant is a minor (under 18)
